I, Sachin Agarwal, Partner of M/s Agarwal S. & Associates, Practicing Company Secretaries, Delhi having Firm's Registration No. P2003DE049100 had been appointed as Scrutinizer by the Board of Directors of Bharat Heavy Electricals Limited ("the Company") pursuant to the provisions of Section 110 of the Companies Act, 2013, Rule 20 & 22 of the Companies (Management & Administration) Rules, 2014 read with Ministry of Corporate Affairs (MCA) General Circular Nos. 14/2020 dated 8<sup>th</sup> April, 2020, 17 /2020 dated 13<sup>th</sup> April, 2020 and 03/2025 dated 22<sup>nd</sup> September, 2025 ("MCA Circulars"), for the purpose of scrutinizing the Postal Ballot voting conducted by way of remote e-voting process on the resolution contained in the Postal Ballot Notice dated 18<sup>th</sup> November, 2025, in a fair and transparent manner.

### 1. Postal Ballot Notice

The Postal Ballot notice dated 18<sup>th</sup> November, 2025 alongwith the statement setting out material facts under Section 102 of the Companies Act, 2013 in respect of the resolution mentioned therein, was sent to all the Shareholders in accordance with the provisions of the Companies Act, 2013 and SEBI (Listing Obligations & Disclosure Requirements), 2015 read with Rules made thereunder together with the MCA Circulars.

# 2. Management's Responsibility

The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the MCA Circulars; and (iii) the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 relating to evoting on the resolution contained in the Notice. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

### 3. Scrutinizer's Responsibility

ICSI Unique Code: P2003DE049100

My responsibility as a scrutinizer for e-voting process is restricted to making a Scrutinizer's report of the votes cast "in favour" or "against" by the Shareholders in respect of the resolution contained in the Postal Ballot Notice. My report is based on verification of data

and reports generated from the voting system provided by National Securities Depository Limited (NSDL), the e-voting agency authorized under the Rules and appointed by the Company to provide e-voting facility and papers/ documents furnished to me electronically till the time fixed for closing of the e-voting process.

#### 4. Cut -off date

The shareholders of the Company as on the "cut-off" date as set out in the Notice i.e. Wednesday, 12<sup>th</sup> November, 2025 were entitled to vote on the resolution set out in the Postal Ballot Notice and their voting rights were in proportion to their shareholding in the paid-up equity share capital of the Company as on the cut-off date.

## 5. Remote e-voting process

- i. The remote e-voting period remained open from Wednesday, 19<sup>th</sup> November, 2025 (9:00 a.m. IST) to Thursday, 18<sup>th</sup> December, 2025 (5:00 p.m. IST).
- ii. The votes cast during the remote e-voting were unblocked after the conclusion of e-voting period for Postal Ballot and was witnessed by two witnesses, Mr. Ravi Agrawal and Ms. Shweta Jain who are not in the employment of the Company and / or National Securities Depository Limited (NSDL). They have signed below in confirmation of the same
