**Brief profile:** Dr. Nalin Shinghal has assumed charge of the post of Chairman & Managing Director on the Board of BHEL w.e.f. 08.07.2019. He has done B.Tech (Electrical Engg.) from IIT-Delhi and PGDM from IIM (Calcutta). He has been a Commonwealth Scholar and done PhD in Transport Economics from the University of Leeds/ UK.

Prior to joining BHEL, he was the Chairman & Managing Director (CMD) of Central Electronics Limited (CEL). He joined CEL in 2013 as CMD, when the company was facing chronic financial sickness with almost 90% net worth eroded. Under his visionary leadership, CEL was successfully turnaround into profit making Company which has been making rapidly growing profits in the past six years.

In his long career span of more than 30 years, he has undertaken various assignments in Private Sector, Public Sector and Government. He has worked with the Indian Railways Traffic Service (IRTS) in various capacities in Operations, Commercial & Marketing functions and also with PSUs in diverse areas i.e. CONCOR, IRCTC and CEL. He has also worked with the Long Range Decision Support group of the Ministry of Railways.
