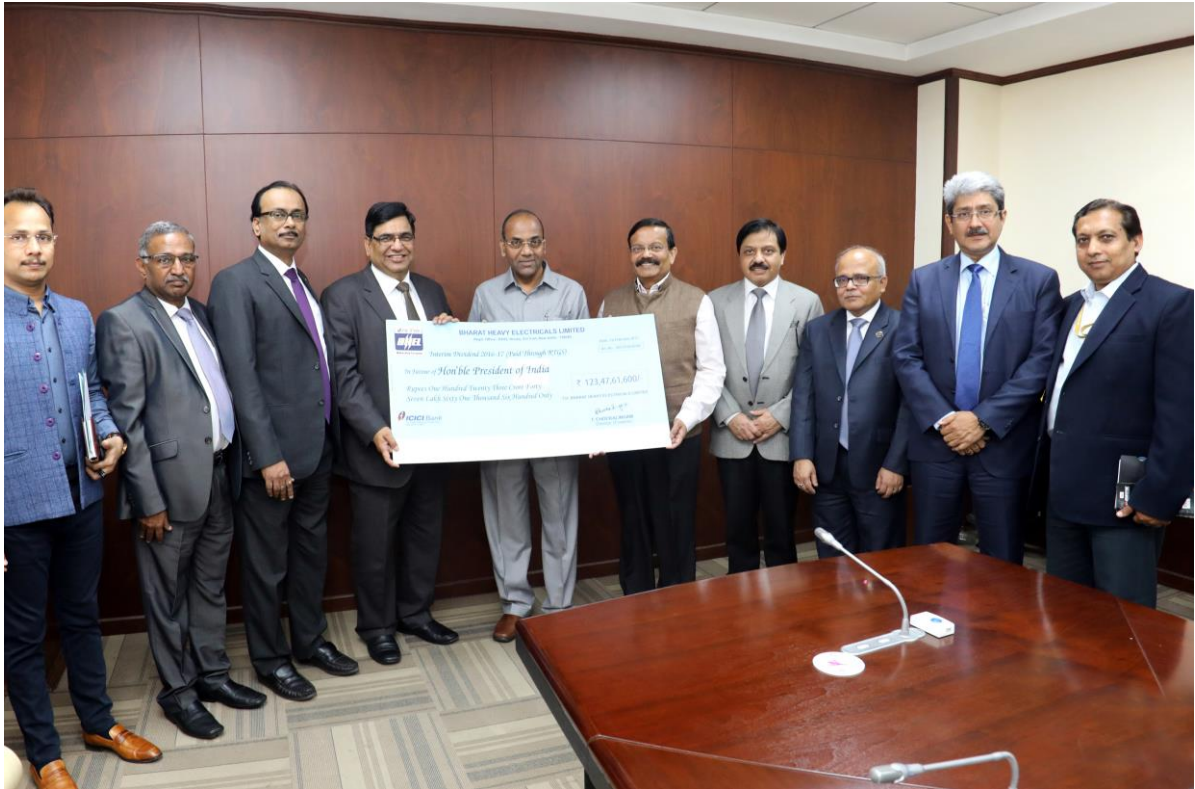


BHEL pays 40% Interim Dividend for fiscal 2016-17
