1	Bank Guarantee: As per Government of India, Ministry of Finance, Department of Public Enterprises Notification .F.No.DPE/7(4)/2007 dated 8.02.2022, Bidder can issue Insurance guarantee. Hence, bidder will have the option to issue either bank guarantee or insurance guarantee.	Tender conditions prevail. PBG to be furnished as per Tender documents.	
2	period of Performance Bank Guarantee (PBG) / Insurance Guarantee is being considered as per tender. But if any delay in Project Execution period beyond 3 months of contract period, then the PBG / Insurance Guarantee has to be returned to the Vendor without any conditions. Further, the claim period as per contract is 3 months. Hence, the BG / insurance guarantee has to be returned immediately after 3 months irrespective of any additional claim period mentioned in the guarantee.	Not acceptable. Tender conditions prevail.	
3	5% of the basic price for supply of plant and equipment against submission and approval of basic / detail engineering drawings on prorata basis has to be released without insisting for bank guarantee.	Tender conditions prevail.	
4	Erection cost is not 15% of the total contract value. However, at the time of tendering and in line with tender conditions, 15% of the total value has been apportioned towards this. If civil fronts and other reciprocal inputs are not handed over by BHEL as per contract schedules, BHEL has to release 50% of erection value on completion of the Project scheduled contract period without any BG / Insurance Guarantee. 5	Project schedule: For both Stacker Cum Reclaimer machines, civil front should be made available to start our erection activities for both SCR machines simultaneously. If civil fronts for either of the machines are not available, the start of erection works will get deferred till both fronts are made available.	Not acceptable ,fronts will be made available in staggered manner as already specified in NIT	
6	Drawings submitted to BHEL for approval should be approved within 15 days. If approval / comments are not given by BHEL, within 21 days from the date of submission, then the drawings are deemed to have been approved and all commercial activities, payments and release of guarantees are to be cleared. Similar timeframe is also applicable to the end customer.	Tender condition prevails, no deemed approval and specific approval from BHEL/NTPC/PVUNL to be obtained.	
7	For enabling timely dispatch of items and to claim payments against MRC, the following timeline is to be followed:  i.Inspection of items have to be completed within 15 days from the date of inspection call.  iii.MDCC has to be issued within 5 days of completion of Inspection or Inspection call.  iii.MRC is to be issued by BHEL within 24 hours of vehicle entering the Project site. Similarly, MRC from the end customer has to be issued within 72 hours.	Tender condition prevails, as onus is equally on bidder.	
8	MCE Insurance is under the scope of BHEL. Hence, once the items are delivered at the project site, it will become the responsibility of BHEL. The project site should be secured by wall / peripheral fencing and there should be control of exit and entry at the Gate by security deployed by BHEL / end Customer to avoid entering of unauthorized persons into the project site. If any theft or any of damage to the items occurs and if there is no possibilities of insurance claim due to minimum claim value condition in the policy, then BHEL has to place a fresh order on Vendor (based on the police complaint lodged) for the supply of stolen / damaged items and payment has to be made without any delays so as to complete the work as per the contract delivery period.	Bidder to ensure proper security, storage & handling of the equipment to avoid any theft / damage whatsoever to the extent possible as the same is in his scope. However, in case if there is any, bidder to support BHEL with all the required documents/proof (as required) for claiming insurance from the insurance company.	
9	Guarantee / Defect Liability Period shall be 18 months from the date of completion of facilities or 12 months from the date of Operational Acceptance of the facilities or 12 months from the date of last major supply, whichever is earlier	Tender conditions prevail.	
10	The last 5% payment has to be released without a BG / Insurance Guarantee If "no load" trial operation of respective machines is not taken up within 3 months of completion of erection due to reasons not attributable to the bidder.	Tender conditions prevail.	
11	With reference to the new clause no.3, Corrigendum no.4 dt.27.2.2022, kindly note that Promac is a MSME registered company and we request you to release all payments within 45 days of presentation of the invoice as per MSME act.
