- 14. Further to SI no. 19 & 20 of SCC (Special conditions of Contract) for 3x800 MW PVUNL PATRATU TPP PHASE-I Project, bidders to note that demurrage/detention charges, if any, claimed by the transporter shall be paid by the Supplier/vendor. The Supplier/vendor agrees that BHEL shall not be liable for any such charges in any case whatsoever. No such claim shall be entertained by BHEL for demurrage/detention charges. No claim on a/c of delay in unloading of the material shall be entertained by BHEL. BHEL shall not be liable for any delay in unloading of the material.

- 16. **Contract Performance Bank Guarantee** shall be as per Cl. no. 11.0 of GCC Rev 07 & Corrigendum to GCC REV. 07. However, BG value shall be 5%. Further in case of BG value reduction, same shall be informed to bidders during bid evaluation or order execution stage.
