### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

#### 1) Performance Bank Guarantee (PBG):

PBG of 10% of total order value is to be submitted by the successful vendor within 15 days from date completion of installation and shall be kept valid upto guarantee period with additional claim period of 3-6 months thereafter. The offers of the suppliers not accepting to this clause will be rejected.

#### 2) Interest of Delayed submission of performance security - PBG:

Bidder agrees to submit performance security required for execution of contract within the time period mentioned. In case of delay in submission of performance security, enhanced performance security which would include interest (SBI rate + 6%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/Contract, from the bills along with due interest.
