NOTICE INVITING EXPRESSION OF INTEREST (EOI)

SUB: EMPANELMENT OF PATHOLOGY LABS FOR SPECIALIZED INVESTIGATIONS (PATHOLOGY, BIOCHEMISTRY AND MICROBIOLOGY) OF KASTURBA HOSPITAL.

Interested parties must submit the documents regarding technical requirement in sealed envelope on or before 12/01/2021.

Scope of work:

Specialized Pathological investigations of (both OPD & IPD) patients of Kasturba Hospital, BHEL, Bhopal will be outsourced. The Pathology labs centres have to submit the reports within the defined period of time. The quality of the reports shall be as per norms as mentioned below: -

Terms and conditions.

- a. Samples for such investigations/ tests are to be collected daily on all working days from Kasturba Hospital laboratory by the party with their own efforts and cost.
- b. Consumables like vacutainer, slides, ice/ dry ice and other necessary items for safe transportation of samples should be arranged & borne by the party.
- c. Facilities to perform all such tests in house is mandatory and list of equipments (with supporting of proof) for the tests on which they will be performed to be attached along with the EOI.
- d. The party should ensure to provide us the accurate reports which can be cross checked at any time. The reports should reach the laboratory within four days of sample collection. In case of failure of performing the tests on time the patient/deptt is advised to get it done from other available sources and difference in price shall be deducted/ recovered from the running bill of the defaulting party.

Qualifying Criteria :


The laboratory must be certified by National Accreditation Board for testing and Calibration of Laboratories (NABL), Deptt. of Science and Technology, Govt. of India and College of American Pathologist (CAP).

1. The document submitted by Laboratories in response to EOI shall contain following documents.
 - a) Certified of "National Accreditation Board of Testing and Calibration Laboratories (NABL), Department of sciences and technology, Govt. of India, New Delhi and "Certified of College of American Pathologist (CAP)" relevant certificate and documents must be submitted along with the EOI by the party.
 - b) License for doing the work from competent authority.
 - c) Provision for on line submission of the test reports/results essential.
 - d) All test shall be done in house without outsourcing to any third party.
 - e) List of clients to whom your services are being provided especially PSUs/ Govt. institutions and other reputed hospitals/ nursing homes for at least one year preferably during last seven years & certificate of job completion to be provided.
 - f) PAN No.
 - g) GST registration no.
 - h) Previous three years audited Balance sheet certified by Chartered account.
 - i) Details of Machines, make& Nos.
2. Bidder shall sign each page of offer and any addition/deletion if any, shall be counter signed. Incomplete or unsigned offer is liable to be rejected.

5. The contractors will be responsible for enforcing all safety regulations applications to carry out investigations installation and equipment etc.
6. Collection of samples from the hospital and sending the reports in time to our hospital is the responsibility of the party to whom the work shall be awarded. Any financial involvement in this process if needed shall be borne by party.
7. All consumables like vacutainers, slides, dry ice etc. necessary for sample transport must be managed by party on their own cost.
8. BHEL Bhopal reserves the right to accept or reject any /all offers without assigning any reason whatsoever.
9. The bidders shall sign on each page of the EOI and documents submitted. Incomplete or unsigned paper is liable to be rejected.
10. In emergency cases, reports should be given to the patient on same day.
11. The empanelment is liable to be terminated for unsatisfactory performance.
12. Facilities for retrieval of reports from the Internet are absolutely essential, which the party has to ensure.
