

**PRE QUALIFYING CRITERIA FOR PROCUREMENT OF 37 KW AC DRIVE PANEL FOR TRACTION MOTOR TEST (VVVF CONTROL TEST).AGAINST PI NO.-140420012, QTY.-1 SETS**

For procurement of 37 kw ac drive panel for traction motor light run test (vvvf control test) for 6FRA6068 motor of WAG-9 locomotive, suppliers should satisfy following qualifying criteria-

**1. QUANTITY DISTRIBUTION**-The total enquired quantity i.e. 1 set shall be ordered on single vendor.

**2. THE AVERAGE ANNUAL FINANCIAL TURNOVER**- Supplier to furnish the copy of balance sheet including profit & loss statement of last three years, ending 31<sup>st</sup> March-2022 duly audited by CA.

The average annual financial turnover of last three years should be minimum rupees 1, 90,364.00 for non- MSMEs vendors and rupees 1, 32,254.00 for MSMEs vendor. In case balance sheet for the last financial year is not yet audited, the unaudited balance sheet of the last financial year can be enclosed along with certificate of CA.

If turnover details of 3 years are not available then available years turnover shall be evaluated by dividing it by 3.

**3. EXPERIENCE**- (A) Supplier must have completed supply of AC drive panel for light run test of 3-phase traction motor or industrial motor for locomotives /DEMU/Rail transport/Industrial application for at least 01 set of machine as per requirement detailed in Annexure-A.

(B) Supplier to furnish PO copy/work completion certificate of successful supply done for least 01 set of machine in last 5 years ending 30-06-2022.

(C) Supplier to furnish Performance certificate of successful supply done for least 01 set of machine in last 5 years ending 30.06.22.

**4. CAPABILITIES** - Supplier to furnish their capabilities w.r.t. personnel, equipment and manufacturing facilities through self-declaration along with an undertaking that they are liable to be proceeded against in case of false declarations, would suffice. The bidder shall also declare that BHEL reserve the right to assess their facilities at random at any point of time and that they agree for penal action from BHEL in case any of the information furnished by them is found to be false.

**5. PAN AND GSTIN CERTIFICATE**- Supplier to furnish copies of PAN card, GSTIN certificate etc. along with offer.

**6. SELF CERTIFICATE /DECLARATION** -Supplier to furnish self-certificate/declaration that

(A) The bidder is not suspended by BHEL Jhansi or any unit/office of BHEL or any other government organization and

(B)The bidder is not guilty by court of law in India for any offence involving fraud, dishonesty and moral turpitude.

**7. POSITIVE NET WORTH**- Supplier to furnish the copy of balance sheet of last three years as mentioned at SL. No.-2 The net worth should be in positive.
