The equipment / material supplied and services rendered (if applicable) shall be guaranteed to be free from all defects and faults in design & engineering, material, workmanship & manufacture and in full conformity with the Purchase Order / Contract, Technical Specifications & approved drawings / data sheets, if any, for 18 months from the date of last delivery or 24 (twenty-four) on completion of successful commissioning", whichever is later. 14. Performance Bank Guarantee: Supplier shall arrange to submit PBG for 10% of the total Ex-works value (excl.
