Bidders who are regular Indian Origin manufacturers of Mill Reject System/ Ash Handling system, having proven design for the type of equipment and have supplied in at least two (2) no. of thermal Power units of 500 MW or above, working satisfactorily for a minimum period of two (2) years within last 7 years from 01.07.2020 may also qualify.</p> <p>b. (i) However all such Indian bidders should have a technology sharing license agreement for the Mill Reject System (Pneumatic type) with a collaborator who is a regular manufacturer of Mill Reject System (Pneumatic type) with at least for the duty specified / required for this project (i.e 5.4 TPH) and meets the criteria as specified in Sl. No. (a) above.</p>
2	<p>Bidder/Associate partner in the bid either himself or his group company shall also be eligible to supply the Mill Reject System (Pneumatic type) if its Parent Company/Subsidiary Company/Group Company/JV Company (equity participation not less than 25%) meets the Criteria fulfilment mentioned against Sl. No.(a) above for each equipment/sub systems in consideration above. Necessary end user credentials meeting the Qualification intent in favour of those entities in whose strength Bidder/Associate partner have selected the proven System/plant/equipment must be submitted to the owner for approval along with the declaration of Legal relationship with such entities.</p> <p>However, in each of such case the bidder/ Associate partner must get the design & engineering documents vetted from all such approved entities in the project.</p> <p>The sub systems/modules/Items/components used in assembling of the complete equipment(s)/system (s) shall be sourced from reputed manufacturers having proven experience with such similar products.</p>

If the bidder does not possess the credentials mentioned at Clause No. 1 or 2 above, they may alternatively submit credentials establishing that they have capabilities for design/manufacture and having in house / outsourced facility for testing of mill reject system (pneumatic type) with minimum rated capacity of 5TPH.</p> <p style="text-align: center;">OR</p> <p>b. Bidder may also qualify based on the credential of principal (Associate/Collaborator/Technology provider/Licenser/Qualified equipment manufacturer) meeting pre-qualifying requirements mentioned at SN. 3 (a). For this bidder has to submit valid technical collaboration / licensing agreement along with scope matrix for execution.</p>
4	<p>The bidder shall submit following supporting documents meeting the above mentioned pre-qualification requirement:</p> <p>Copy of performance certificate/s (in English) from the End user/s along with copy of related Purchase Order/s (PO) or Letter of intent (LOI/s) or Letter of Award (LOA/s) or Work Order (WO/s) in support of credential above.</p>

5	Bidder shall submit all necessary data such as type, design, make, capacity, duty conditions, date of commissioning/ operation etc. to substantiate technical parameters specified in PQR, if the same is not mentioned in performance certificate/purchase order.
6	Bidder to submit all supporting documents in English. If documents submitted by bidder are in language other than English, a self-attested English translated document should also be submitted.
7	Minimum one (1) no. PO/ LOI/LOA/WO shall be submitted which should not be more than seven (7) years old, for establishing continuity in business. This is over and above the requirement of PO/ LOI/LOA/WO mentioned at Sl. no. 4 above.
8	Notwithstanding anything stated above, BHEL/WBPDCL reserves the right to assess the capabilities and capacity of the bidder to perform the contract, should the circumstances warrant such assessment in the overall interest of BHEL/WBPDCL.
9	Consideration of offer shall be subject to WBPDCL's approval of bidders, if applicable.
10	After satisfactory fulfilment of all the above criteria/ requirement, offer shall be considered for further evaluation as per NIT and all the other terms of the tender.
11	The bidders approved by WBPDCL for Mill Reject System (Pneumatic Type) for 1x660 MW Sagardighi Extension Project need not submit credentials as specified in this document. The list of approved suppliers by WBPDCL are as per Annexure – 1.

Notes:

- Please note, PQR indicated at Clause No. 1 & 2 is requirement of BHEL's end customer (M/s WBPDCL) with respect to capacity, place of installation (type of Industry) & duration and to be considered by M/s WBPDCL while approving the bidder.
- Bidders are advised to furnish the PQR documents in line with Clause No. 1 or 2 which is specific requirement of BHEL's end customer. However, in case the bidder feels that they are not meeting the requirement of Clause No. 1 or 2 , but can meet the requirement of Clause No. 3 (a) or 3 (b) , they are advised to submit the bid along with PQR documents meeting the Clause No. 3 (a) or 3 (b). **The bids meeting the requirement of Clause No. 3 (a) or 3 (b) shall be technically recommended by BHEL and shall be forwarded to end customer for acceptance with respect to Clause No. 3 (a) or 3 (b) and shall be subject to approval of the bidder(s) by M/s WBPDCL.**
- In case BHEL's end customer (M/s WBPDCL) does not consider any relaxation with respect to Clause No. 3, the bids and bidder's approval shall be solely governed with respect to Clause No. 1 , 2 of the PQR and bidder shall not have any claim with respect to Clause No. 3 (a) or 3 (b).**
