The bidder should have designed, manufactured, erected and commissioned at least two (2) EOT cranes within seven (7) years, which are in successful operation in at least two (2) separate power stations of unit rating 500 MW or more for the minimum period of two (2) years as on 01.07.2020.</p> <p style="text-align: center;">OR</p> <p>B. The bidder should have designed, manufactured, erected and commissioned at least two (2) EOT cranes of capacity 160 Tons or more within seven (7) years, which are in successful operation in at least two (2) separate industrial projects for the minimum period of two (2) years as on 01.07.2020.</p>
2	If the bidder does not possess the credentials mentioned at Clause No. 1 above, they may alternatively submit credentials establishing that they have designed, manufactured, erected and commissioned at least one (1) EOT /Gantry / Semi-Gantry crane of capacity 100 Tons or more with minimum span of 24 meters, which is in successful operation in at least one (1) station (i.e., Power Plants, Manufacturing Units, Cement Factories, Oil Refineries, Shipyards, Steel Plants etc.) for a minimum period of one (1) year as on 01.07.2020.
3	<p>The bidder shall submit following supporting documents meeting the above mentioned pre-qualification requirement:</p> <p>Copy of minimum one (1) performance certificate (in English) from end user along with copy of related Purchase Order (PO) or Letter of intent (LOI) or Letter of Award (LOA) or Work Order (WO) in support of credential above.</p>
4	Bidder shall submit all necessary data such as type, design, make, capacity, duty conditions, date of commissioning/ operation etc. to substantiate technical parameters specified in PQR, if the same is not mentioned in performance certificate/purchase order.
5	Bidder to submit all supporting documents in English. If documents submitted by bidder are in language other than English, a self-attested English translated document should also be submitted.
6	Minimum one (1) no. PO/ LOI/LOA/WO shall be submitted which should not be more than seven (7) years old, for establishing continuity in business. This is over and above the requirement of PO/ LOI/LOA/WO mentioned at Sl. no. 2.0 above.
7	Notwithstanding anything stated above, BHEL/WBPDCL reserves the right to assess the capabilities and capacity of the bidder to perform the contract, should the circumstances warrant such assessment in the overall interest of BHEL/WBPDCL.
8	Consideration of offer shall be subject to customer's approval of bidders, if applicable.
9	After satisfactory fulfilment of all the above criteria/ requirement, offer shall be considered for further evaluation as per NIT and all the other terms of the tender.
10	<b>The bidders approved by WBPDCL for the supply TG Hall EOT Crane for 1x660 MW Sagardighi Extension Project need not submit credentials as specified in this document (Clause No. 1 or 2). The list of approved suppliers by WBPDCL is annexed as Annexure – 1.</b>
11	The bidder should be an OEM and will meet PQR based on its own credentials. Bid from joint venture (JV) company /Consortium is not acceptable.

1. Please note, PQR indicated at Clause No. 1 is requirement of BHEL's end customer (M/s WBPDCCL) with respect to capacity, place of installation (type of Industry) & duration and to be considered by M/s WBPDCCL while approving the bidder.
2. **BHEL has taken up with M/s WBPDCCL for rationalisation with respect to the capacity, installation & duration which are indicated at Clause No. 2 and under their consideration.**
3. Bidders are advised to furnish the PQR documents in line with Clause No. 1 which is specific requirement of BHEL's end customer. However, in case the bidder feels that they are not meeting the requirement of Clause No. 1, but can meet the requirement of Clause No. 2, they are advised to submit the bid along with PQR documents meeting the Clause No. 2. **The bids meeting the requirement of Clause No. 2 shall be technically recommended by BHEL and shall be forwarded to end customer for acceptance with respect to Clause No. 2 and shall be subject to approval of the bidder(s) by M/s WBPDCCL.**
4. **In case BHEL's end customer (M/s WBPDCCL) does not consider any relaxation with respect to Clause No. 2, the bids and bidder's approval shall be solely governed with respect to Clause No. 1 of the PQR and bidder shall not have any claim with respect to Clause No. 2.**
