Your offer shall be submitted in two parts (Techno-Commercial Bid and Price Bid) strictly as per Clause-2.0 of the "Instructions to Bidders" of GCC, Rev. 07 online via e-Procurement System for the under mentioned equipment/system.

#### 1. Delivery Schedule:

#### a). Supply (incl. Commissioning spares and Maintenance Tools & tackles):

Within Five (05) months from date of CAT-1 approval of Primary drawing/documents, subjected to drawing/document submission/re-submission schedule as stipulated, in case of any delay in submission/re-submission of Primary drawing/documents, then same shall be reduced from the given delivery period. Delay in BHEL's comments/approval beyond 18 days shall also be considered for delay analysis.

List of primary/secondary drawing/documents and their submission schedule shall be as per attached **Annexure-A**.

### b). Supply of Mandatory Spares

Within Three (03) months from BHEL clearance. Separate manufacturing clearance will be issued for Mandatory Spares.

#### c). Supervision of E&C:

Vendor to depute its service engineer for Supervision of E&C within 15 days from BHEL's intimation (for deputing service engineer).

For delay in deputing service engineer, LD on Supervision of E&C portion shall be applicable @ ½% of the total Supervision of E&C portion contract value (excluding element of taxes) per week or part thereof, with applicable GST. However, total LD (supply + Supervision of E&C) shall be limited to 10% of cumulative total contract value excluding taxes and freight (supply + Supervision of E&C).

#### Notes:

**i.** The end period specified is for completion of the deliveries. Deliveries to start progressively so as to meet the completion schedule.

**ii.** The delivery conditions specified are for contractual LD purposes, however BHEL may ask for early deliveries without any compensation thereof.

**iii.** Wherever schedule of drawings/documents submission / re-submission is stipulated in the Technical Specifications, same shall be superseded by delivery specified in NIT.

- Pre-Qualifying Requirements: Bidders who fulfil the TECHNICAL PRE-QUALIFICATION REQUIREMENT CRITERIA are eligible to participate in this tender. Bidders are requested to provide the details as per "TECHNICAL PRE-QUALIFYING REQUIREMENTS". Bids of only those bidders shall be evaluated who meet the Technical Pre-Qualifying requirements.
- 3. Verification of PQR documents: Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of document/certificate issuing authority such as name & designation of Issuing Authority and its organization contact number and e-mail Id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.
- 4. PQR for MSME/Start-Up vendor's: This item/Package/System falls under the list of items defined in Para 3 of Ministry of Finance guideline dated 20-09-2016 (procurement of items related to public safety, health, critical security operations and equipments, etc) & hence criteria of prior experience/turnover shall be same for all the bidders including startup/MSME.
- Tender Evaluation Evaluation will be done on Total cost to BHEL (excluding GST) basis combined for both projects as per Cl. No. 19.2 of Instruction to Bidders of GCC, Rev. 07 with necessary loading (Technical & Commercial) as applicable
  Ordering shall be done after de-loading the commercial/ technical loading from bidder's final price.
- 6. All corrigenda, addenda, amendments, time extensions, clarifications etc., to the tender will be hosted on (<u>https://bhel.abcprocure.com</u>, <u>https://www.bhelpem.com/Home.aspx</u>, <u>http://www.bhel.com/tender/corrigendum\_home.php</u>) under subject tender reference. De-loading (if any) shall be done in line with NIT terms.
- 15. Bidder to note that this is an Open Tender enquiry & Price Bid opening shall be subject to following condition:
  - a. Qualifying Technical PQR and Techno-commercial acceptance of offer by BHEL-PEM.

- 17. In case of joint bidding Bidders to furnish scope matrix which should be clearly defined between them along with the offer for the Main Supply & site activities.
- 18. If any bidder uploads price bid in the unpriced section (techno-commercial attachment page) of the tender in e-procurement, in that case bidder(s) shall only be responsible for such mistake and any consequences thereof. Hence all bidders are requested to be more careful at the time of uploading the Unpriced and Price Bid for Part-I and Part-II respectively to avoid mismatch.
- 19. Commercial terms of NIT only to be considered and mentioned anywhere in technical specification in case contradicting to be ignored.
- 20. Bidders to note that offers shall be submitted strictly in accordance with the requirements of the all the enclosed tender documents. Those documents shall automatically become the part of the Order/Contract after its finalisation.
- 21. Over all (%) quantity variation: The variation on overall package value due to changes in the scope shall be as per clause no 6.0 of GCTC of GCC-REV-07.
- 22. All Bidders to comply Govt. of India, Ministry of Power, order no-25-111612018-PG dtd 02/07/2020 regarding mandatory testing of all the imported items/equipment's/components.
- 23. **Make in India:** This package is divisible in nature. Minimum Local content for this package is 100%. Margin of purchase preference shall be 20%.

In place of clause no 26 of (ITB) GCC-REV-07, following clause shall be applicable:

For this procurement, Public Procurement (preference to make in India), order 2017, Dt: - 15.06.17, 28.05.18, 29.05.19 & 04.06.2020 and subsequent orders issued by the respective nodal ministry shall be applicable even if issued after issue of the NIT but before finalization of contract/PO/WO against the NIT. In the event of any nodal ministry prescribing higher or lower percentage of purchase preference and / or local content in respect of this procurement, same shall be applicable. Vendors are requested to go through the above-mentioned orders and confirm the following: -

-The local supplier at the time of tender, bidding, solicitation, shall be required to provide selfcertification/auditor's certification that the item offered meets the minimum local content as per above mentioned orders and shall give details of location(s) at which the local value addition is made.
