PRE QUALIFYING CRITERIA FOR PROCUREMENT OF INSTRUMENTATION REQUIRED FOR COMMISSIONING AND FIELD-TESTING OF THE EQUIPMENT.AGAINST PI NO.-140420014, QTY.-1 SETS

For procurement of Instrumentation required for commissioning and field-testing of the equipment, suppliers should satisfy following qualifying criteria-

1. **THE AVERAGE ANNUAL FINANCIAL TURNOVER**- Supplier to furnish the copy of balance sheet including profit & loss statement of last three years, ending 31st March-2022 duly audited by CA.

The average annual financial turnover of last three years should be minimum rupees 33,500 for non- MSMEs vendors and rupees 23,500.00 for MSMEs vendor. In case balance sheet for the last financial year is not yet audited, the unaudited balance sheet of the last financial year can be enclosed along with certificate of CA.

If turnover details of 3 years are not available then available years turnover shall be evaluated by dividing it by 3.

2. **EXPERIENCE** (A) Supplier must have completed supply of Instrumentation like multimeter, clamp meter etc. for locomotives /DEMU/Rail transport/industrial application for at least 05 set of machine as per requirement detailed in Annexure-A.

(B) Supplier to furnish PO copy/work completion certificate of successful supply done for least 01 set of machine in last 7 years ending 30-06-2022.

3. **CAPABILITIES** - Supplier to furnish their capabilities w.r.t. personnel, equipment and manufacturing facilities through self declaration along with an undertaking that they are liable to be proceeded against in case of false declarations, would suffice. The bidder shall also declare that BHEL reserve the right to assess their facilities at random at any point of time and that they agree for penal action from BHEL in case any of the information furnished by them is found to be false.


4. **PAN AND GSTIN CERTIFICATE**- Supplier to furnish copies of PAN card, GSTIN certificate etc. along with offer.

5. **SELF CERTIFICATE /DECLARATION** -Supplier to furnish self-certificate/declaration that

(A) The bidder is not suspended by BHEL Jhansi or any unit/office of BHEL or any other government organization and

(B)The bidder is not guilty by court of law in India for any offence involving fraud, dishonesty and moral turpitude.

6. **POSITIVE NET WORTH**- Supplier to furnish the copy of balance sheet of last three years as mentioned at SL. No.-2. The net worth should be in positive.
