NOTE:-

- The quantity will be released for manufacturing in more than one lot.
- Manufacturing of first lot quantity shall be done after approval of technical and quality documentation & supply of the same shall be completed within time period stipulated in NIT.
- Subsequent lot shall be cleared for manufacturing based on progress of engineering & site requirement and supply of the same shall be completed within time.
- Quantity variation shall be as per the NIT condition.
- Vendor to mention HSN Code in specific Column for each item of BOQ.
- In case of discrepancy in GST rate corresponding to HSN code and quoted GST, the evaluation shall be done on quoted price and correct GST rate shall be considered for ordering (limited to quoted FOR Site price)
- Unless the context requires otherwise, in all tenders and tender related documents any reference to taxes such as ED, CST/VAT, Services. Tax etc. shall refer to GST as implemented by GOI w.e.f. 1.07.2017.
- CGST/SGST/UGST/IGST shall be paid at actuals against documentary evidence but restricted to the amount and percentage in the order/contract.
- In case, any GST credit is delayed/denied to BHEL due to non/delayed receipt of goods and/or tax invoice or expiry to timeline prescribed in the relevant Act for availing such ITC, or any other reasons not attributable to BHEL, tax amount shall be recoverable from the vendor/contractor along with interest levied/leviable on BHEL.
- All taxes and duties other than CGST/SGST/UGST/IGST shall be deemed to be included in the Ex-Works prices unless specified otherwise by the bidder in the price bid. No variation in other taxes and duties shall be payable by Purchaser.
- Quantities indicated above shall be known as Order Quantities. The variation in quantities shall be as per NIT.
- Freight to be provided as % of Total Ex-works price.
